

The Club Browser Extension Privacy Notice

Please carefully read this Privacy Notice before installing or using The Club Browser Extension (also referred to herein as our “Clubpoints Catcher”). This Browser Extension Privacy Notice, together with [The Club Terms and Conditions](#), [Terms of Use](#) and [Privacy Policy](#), which are hereby incorporated by reference, form a legally binding agreement (collectively, the “Agreement”) that governs your use of Browser Extension provided by Club HKT Limited (“The Club,” “we,” or “us”). By clicking the “Add to Chrome” or “Install” or similar buttons (as applicable), or by installing, activating, enabling, using, or otherwise accessing the browser extension, you acknowledge and accept the disclosures herein and agree to be bound by the Agreement. If you do not wish to be bound by the Agreement, do not click “Add” or “Install” and do not install, activate, enable, access, click, or otherwise use the browser extension.

1. Clubpoints Earning. Clubpoints Catcher is a browser extension made available to enhance your Clubpoints earning experience with The Club (<https://www.theclub.com.hk/>) by providing you with relevant offers and references displayed on your browser. When you visit certain websites, Clubpoints Catcher may display Clubpoints earning opportunities and prompt you to start your Clubpoints earning session via <https://www.theclub.com.hk/>. If you start a Clubpoints earning session, you will be directed to The Club website. Cookies will be set on your computer for the purpose of tracking your Clubpoints earning sessions. Please note, however, that if Cookies or other similar tracking devices from other companies related to that merchant are already present on your computer, or due to any reasons the Cookies and/or tracking functions are not working properly, you agree that The Club shall not be held liable for any loss or damage caused by or in connection with the malfunction and/or discontinuation of the Browser Extension and/or any Cookies and/or tracking related functions.

2. No Personal Data. When you are interacting with and/or using Clubpoints Catcher, you agree that The Club can surface relevant offers, such as when Clubpoints earning opportunities are available with designated merchants. Clubpoints Catcher will only be used to enhance your Clubpoints earning experience and no personal data will be collected by Clubpoints Catcher.

3. Your choices. You may turn off certain browser activities by visiting the “Settings” option within Clubpoints Catcher. You may also turn off all data collection by uninstalling Clubpoints Catcher.

4. Updates. We may update Clubpoints Catcher when a new version is released or when new features are added and these updates occur automatically. The Club is entitled to amend the Agreement from time to time and all handling of data will be governed by the most recent version of the Agreement, available on The Club’s website. We reserve the right to add features or functions to Clubpoints Catcher but have no obligation to make available to you any subsequent versions or new features that may be included in some versions of Clubpoints Catcher.

5. In the event of discrepancy or inconsistency between the English and Chinese versions of this Privacy Notice, the English version shall prevail. In the event of dispute, decisions made by The Club will be final and binding.
